WHEREAS, the Director of the Division of Local Government Services has the discretion to approve the Authority's budget if not filed by November 1 of the preceding fiscal year if said budget is accompanied by a resolution of the Authority stating the reason, satisfactory to the Director, why the Authority had not submitted its budget on or before November 1; and

WHEREAS, the Commissioners hereby state that they believed that the 2012 Budget was adopted at a regular public meeting on June 19, 2012 by Resolution 06-23-12. Subsequently at a regular public meeting held on October 16, 2012, Resolution 10-39-12 was adopted which rescinded Resolution 06-23-12. Thereafter the Authority adopted Resolution 10-40-12 which amended the introduced budget. The Commissioners than voted on Resolution 10-31-12 representing what they believed to be the adoption of the final amended 2012 budget. Due to an oversight, the final adopted amended 2012 budget was invalid. Upon submission of the 2013 Budget to the state, the Authority was notified that the 2012 introduced Budget had not been approved by the state therefore, the October 16, 2012 adoption was not valid.

NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of the Beachwood Sewerage Authority, that the Director of the Division of Local Government Services be duly notified, by approval of this resolution, that the reason for the delay in adopting the 2012 Authority Budget was as expressed in the above paragraph; and

BE IT FURTHER RESOLVED, that the Commissioners of the Beachwood Sewerage Authority request the Director to approve the Authority's 2012 budget with amendments, if any, at the scheduled meeting of January 15, 2013; and
